If the Owner does not inform immediately regarding measures to be taken, or if the state of the Dog(s) health reasonably demands quick action, I shall have the right to call a veterinarian of choice or administer medicine or give other advisable attention, within my discretion and judgment. Owner will refund any and all expenses incurred promptly. The Owner represents that he is the legal owner of said Dog(s), and that said Dog(s) has not been exposed to distemper or rabies within the last thirty days, all vaccinations including rabies, distemper, and bordatella are current, flea control is used and the required annual license has been obtained from the county which the Dog(s) and Owner resides.
